A. Upon approval of the Director or his designee, this permit guarantees a cabin reservation so long as the reservation permit is completed and signed by an authorized group representative, and received along with a **\$50 deposit within 10 days** of making a confirmed phone or email reservation. The deposit secures the reservation, and is not refunded due to cancellation. The remaining balance of the reservation charge is due within 30 days of the reserved date(s), or within 10 days of making a confirmed phone or email reservation, or within 24 hours of occupying the cabins – **whichever comes first**. If the completed permit and payment are not received on time, the Conservation Board will no longer hold this reservation. See Cabin Rules and Procedures for more information about cabin use. **There is a two-night minimum stay on weekends, and three-night minimum stay on Memorial Day and Labor Day Weekends.**
