**A.** Upon approval of the Director or his designee, this permit guarantees a camp site so long as the reservation permit is completed and signed by an authorized group representative, and received along with the reservation fee (Part C) within 10 days of making a confirmed phone or email reservation, or within 24 hours of the reservation time, whichever comes first. If the completed permit and payment are not received on time, the Conservation Board will no longer hold this reservation. This form allows only one unit on one reserved site. It is allowable to reserve a second unit on the same site upon request – all fees are the same, and a second form must be completed. **Only units with advanced reservations may be on the site.**
